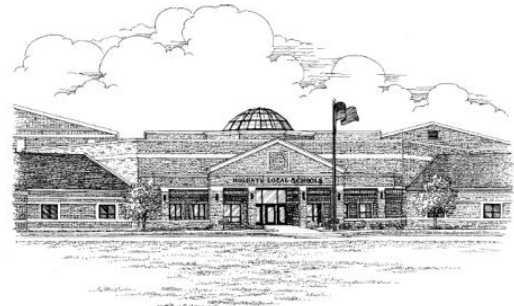

## College Credit Plus Intent Form

We have attended a meeting approved by Holgate school officials explaining College Credit Plus. Through appropriate and adequate counseling, we understand our responsibilities in the program.

\_\_\_\_\_ Option 1

I (my child) will take college coursework for college credit or both college and high school credit simultaneously. Expenses for this option are the responsibility of the student/guardian. I (my child) will take the courses for:

\_\_\_\_\_ Option 2

I (my child) will take college coursework for both high school and college credit. Expenses for this option are the responsibility of Holgate Local Schools unless the student fails to successfully complete the course (late drop from the class, nonattendance/removal from the class, or "F" earned).

\_\_\_\_\_ I understand that expenses under Option 2 of College Credit Plus are the responsibility of Holgate  
 (Student initials) (Parent initials) Local Schools upon successful completion. I understand that earning a final grade of "F" and/or dropping a course after the 14<sup>th</sup> day of class at the college are circumstances in which financial obligation falls back on the family.

\_\_\_\_\_ I understand that if courses are dropped at any point after supplies are purchased, financial  
 (Student initials) (Parent initials) obligation for these supplies falls back on the family.

\_\_\_\_\_ When receiving high school credit, I agree that just prior to the end of Holgate's 1<sup>st</sup> and 3<sup>rd</sup>  
 (Student initials) (Parent initials) quarters I (my child) will print off current college grades, along with a syllabus, for each course and turn them in to the Guidance office. Grades for the 2<sup>nd</sup> and 4<sup>th</sup> quarters will be taken directly from college transcripts. These grades will be on the high school grade card and factored into quarter GPA (honor roll & eligibility). Failure to turn in college grades will result in an "Incomplete" which will affect honor roll and eligibility.

If CCP courses are scheduled at the beginning or end of the school day, students are permitted to arrive late to school and leave early from school. Because the school is responsible for student safety and well-being, permission is required to deviate from the typical schedule. Your initials below, and final signatures, releases the school from any and all liability during the hours that you (your child) is not scheduled in the school building. Students must sign in or sign out of the building in the Middle/High School Office upon late arrival or prior to early dismissal.
